Any member or non-connected member would pay the regular fee of \$6.00 a thousand as regular members as they pay the \$240.00 a year up front. A motion was made to charge the non-members \$32.00 a month for the first 2000 gallons, and \$10.00 a thousand for every thousand after that. Motion second and passed.

A Motion to except the Hart Ranch proposal of \$630.00, for passed charges, and beginning in 2021 assessing them at our scheduled rate. Motion second and passed.

It was noted that we no longer, according to the lawyer, have any binding contract with the Hart Ranch on their well.

Rick Wipf duplicate tap was discussed. It was decided that he should only have 1 tap to duplicate. A letter needs to be sent to him.

An estimate to paint the reservoir came in at \$24,000.00. A motion to paint the tank was made, second and passed.
